

#### **HMO**

HMO members have access to the HAP Visitor/Travel benefit when traveling to Arizona, Florida, Texas or outside of our service area in Michigan.

Members will pay innetwork cost-share for routine care when seeing any Medicare approved provider in Arizona, Florida, Texas, or outside of our service area in Michigan.

#### **HMO-POS**

Members will have access to their Point-of-Service benefit when seeking routine care outside of the HAP network.

Members have the flexibility to see any Medicare approved provider across the country for out-of-network routine care up to their POS maximum benefit.

Members will be subject to their POS cost-share.

#### **PPO**

**NEW** for 2021 PPO members have access to the **HAP Visitor/ Travel benefit** when traveling to any 49 states outside of Michigan.

Members will pay the in-network cost-share for routine care when seeing any Medicare approved provider in any of the 49 states outside of Michigan

Michigan is excluded from this benefit for PPO members. Members can use their OON benefit to access OON providers in Michigan.

HAP will be participating in the voluntary CMS model that allows us to lower members out-of-pocket cost for insulin to a maximum \$35 copay per 30-day supply in all Part D phases.

This benefit applies to select insulins on the HAP formulary (Examples: Novolog, Lantus, Tuejeo)





### Value Based Enrollment



#### What is VBE?

The value-based enrollment (VBE) program is an extension of the enrollment application process through <u>Ascend</u>. It's designed to immediately engage your clients with their new HAP Medicare plan (MA/MAPD) and gather helpful health-related insights from the enrollee. After enrolling clients in an MA/MAPD plan, you can offer the VBE option. If interested, your clients can then participate in a voluntary 15 minute phone call with a wellness advocate to discuss their health goals, risks and ambitions.

# HAP Medigap Plans







HAP offers plans A, C\*, D, F\*, G and N.

A, C, D and F are available for guaranteed issue for loss of creditable coverage.

\*C and F are only available to beneficiaries eligible for Medicare prior to 1/1/2020

Under 65 can buy plan A if eligible for Medicare after 1/1/2020 or plan A and C if eligible for Medicare prior to 1/1/2020



### **Eligibility**

To be eligible, beneficiaries must be a permanent resident of Michigan and have Original Medicare (Part A and Part B)

Guaranteed Issue rates are determined by age and gender

Underwritten applications may qualify for preferred rates, standard rates or be denied.

Plan is portable if leaving Michigan after 6 months. Rates do not change.



#### **Household Discount**

HAP offers a \$10/PMPM household discount.

If 2 members of the same household are applying for a HAP Medigap plan, they both may receive a \$10/month discount on your premium

If another member of your household is already an active HAP Medigap plan member, the new member may receive a \$10/month discount on the premium for the current plan year.

If two people in the same household were members prior to 1/1/2020 they are not eligible for the discount unless they reapply and go through UW.



# Medigap Trends





#### **MACRA**

Effective January 1, 2020 beneficiaries newly eligible for Medicare on or after January 1, 2020 are not eligible to purchase Plan C or F.

Plan G is the most comprehensive Medigap plan available to Medicare beneficiaries who became eligible for Medicare on or after January 1, 2020.

Plan G does not cover the Medicare Part B Deductible.



# Medicare Part B Deductible

In 2015 the Medicare Part B deductible was \$147

Today the Medicare Part D deductible is \$198.

Medicare Part B Deductible has increased by 35% over 5 yeas and may continues to rise



### **Medigap Premiums**

The average annual Medigap premium increase is 5-10% annually

Medigap premiums are impacted annually by beneficiary age and yearly rate filings by the insurance company

Medigap premiums do not included the Part D premium



### Michigan Medigap Subsidy

The Michigan Medigap Subsidy is expected to run out sometime in 2021.

Beneficiaries receiving this subsidy will face a premium increase between \$35-\$110 per month

# **Enrollment Opportunity**







Medicare Beneficiaries on Traditional Medicare or Traditional Medicare and Medigap can only use AEP to enroll into a Medicare Advantage unless they qualify for an SEP.

Annual Election Period runs from October 15th-December 7th



# Medicare Advantage Open Enrollment Period

Medicare Beneficiaries on Traditional Medicare or Traditional Medicare and Medigap are prohibited from using the MA-OEP to switch from Medigap and/or Traditional Medicare to Medicare Advantage.

MA-OEP runs from January 1st – March 31st

# Medicare Advantage Trial Right





### Are your clients hesitant on making the switch? Help them understand their rights.

Medicare Beneficiaries have the right to exercise their **Medicare Advantage Trial Right** once in their lifetime.

If your client drops a Medigap policy to join a Medicare Advantage plan for the first time, and they've been in the Medicare Advantage plan less than a year, they have the right to switch back to Medigap GI.

Beneficiaries must go back to the Medigap policy they left and will be issued the plan at the same rate they had before they termed the coverage. You will see the Trial Right election on all Medigap applications.

If the Medigap policy they left is no longer available then they can choose to buy any Medigap plan A, C, D, F, G, K or L that is sold in their state and will be GI.

To put them back into the PDP they had you will use the trial right SEP on the PDP application.

Medigap commissions typically do not pay lifetime or if they do, the amount is very small compared to Medicare Advantage.

Medicare Advantage commissions, per CMS regulations, pay lifetime.

Medicare Advantage commissions have experienced a 32% increase over the past 5 years and when HAP raises the Medicare Advantage commissions it goes up for both existing and new business.
