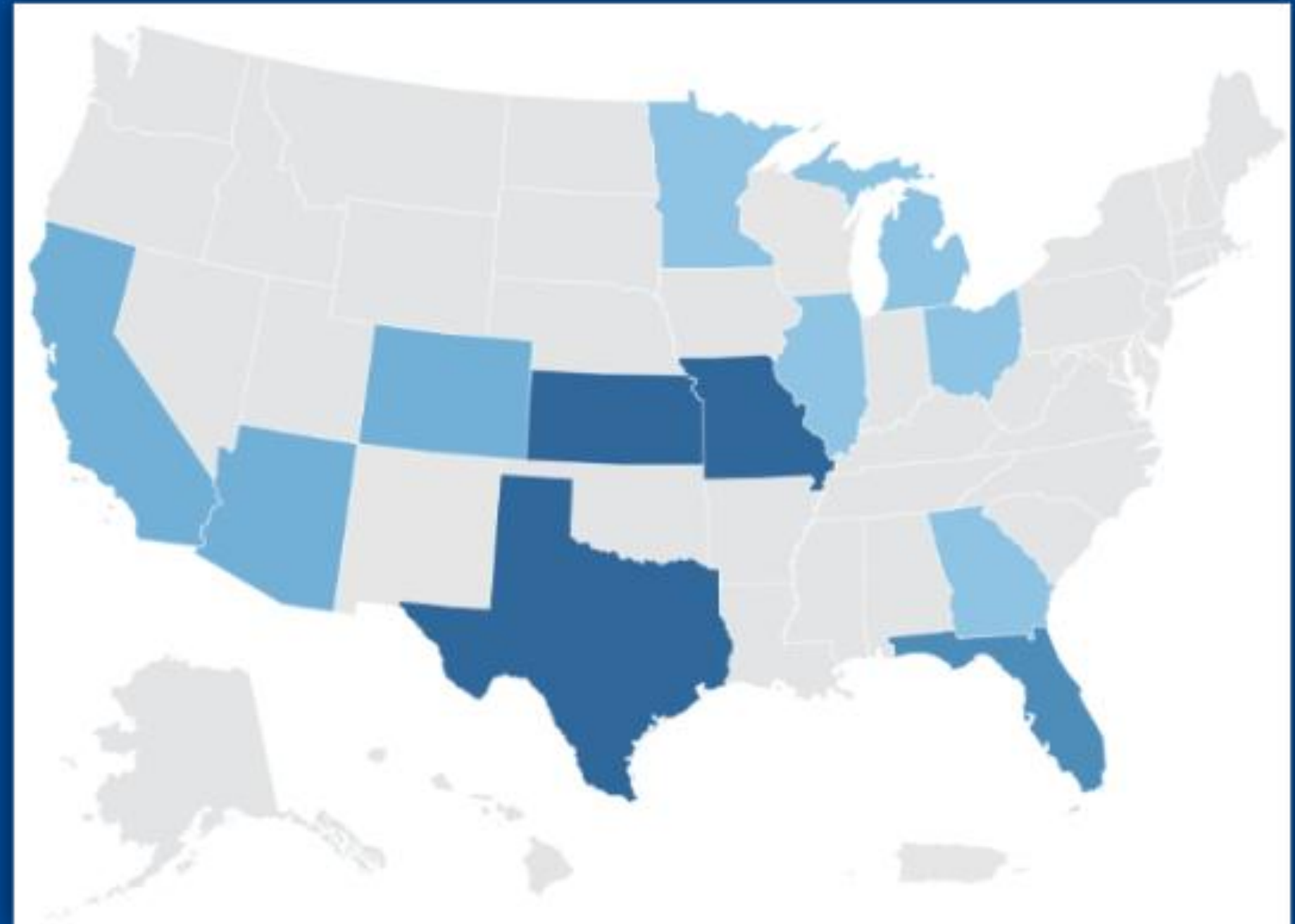

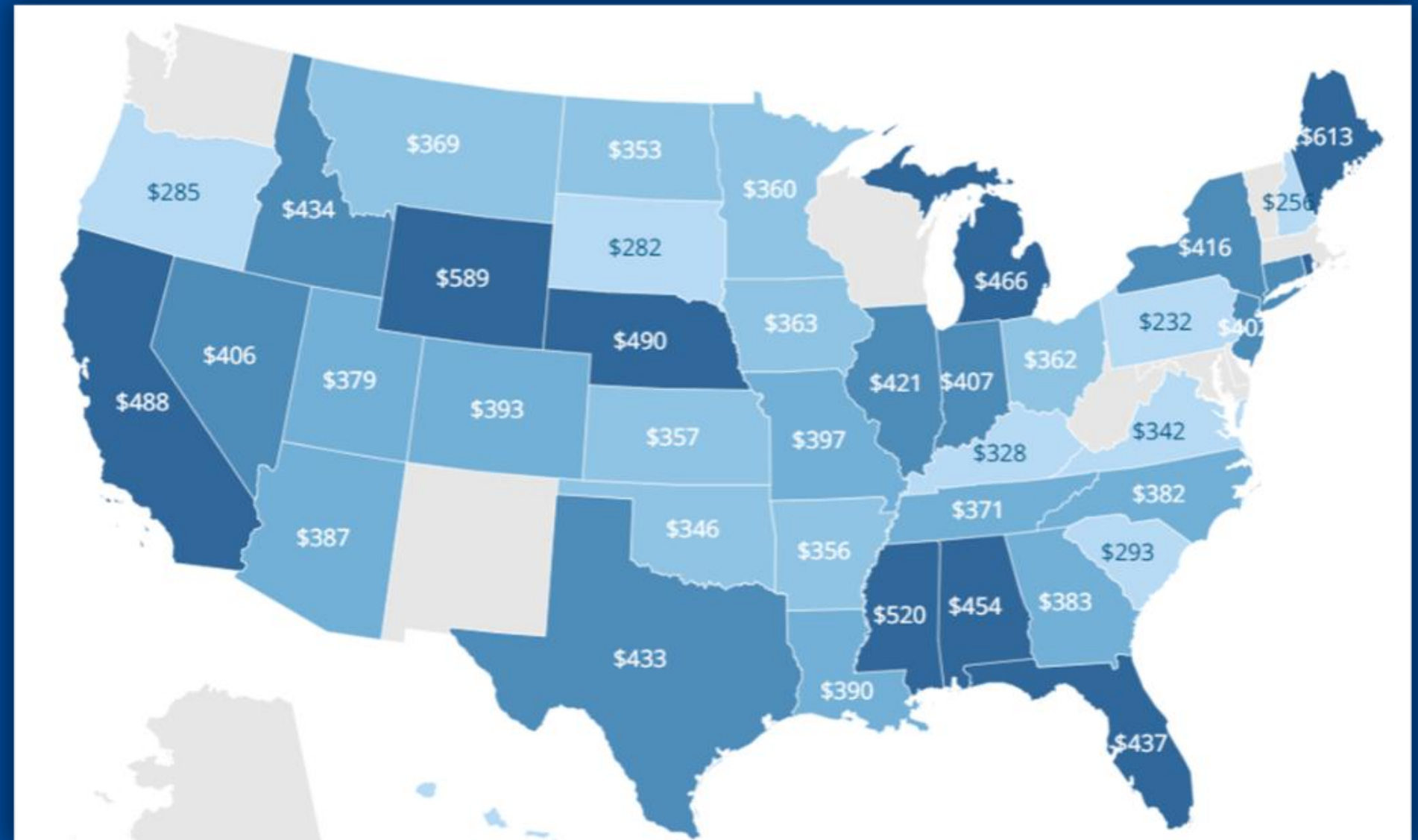

Easy as 1, 2, 3!

Step 1 - Telemedicine

Remember that Smart Virtual Care (Telemedicine) is always a \$0 Visit Fee at OneShare Health. Make this your first line of defense for common ailments!

Step 2 - Check Your Program Features

For conditions more serious than those that could be resolved with Telemedicine through Clever Health, but which are not Life-Threatening or Life-Altering, your next line of defense is your Primary Care Physician or an Urgent Care Facility.

Step 3 - Find a Provider

Our Members have access to an easy-to-use Provider Locator tool to search for doctors. Members are not required to use First Health but could end up with additional sharing responsibility if they choose an out-of-network Provider.




**What if
the Provider is
Out-Of-Network
and the Member
receives a
balance bill?**

Medical bills from Out-Of-Network Providers will be processed and OneShare Health will work with Providers to find an appropriate reimbursement amount. If a Member receives a balance bill, they should first contact OneShare Health before paying anything and email the balance bill to Correspondence@OneShareHealth.com.

Our team of Specialists will work with the Provider and advocate on the Member's behalf to significantly reduce their charges, keeping the cost of services as affordable as possible.





What if the Provider requires payment upfront?

If payment is required by the Provider that day, the Member should ask for a self-pay or cash-pay rate, which should be much less than the usual billed charges.

If they pay a bill on the date of service, they should:

1. Keep all applicable records and receipts
2. Fill out the Expense Sharing Request Form
3. Submit both directly to OneShare Health
4. The eligible amount (minus Visit Fees/ISA) will be reimbursed to the Member
